BID SOLICITATION AMENDMENT # 001

This amendment is being issued to affect the following;

- 1. Re-initiate the solicitation process;
- 2. Respond to bidder question from the previous solicitation R00016006/B;

1. As a follow-up to the solicitation R00016006/B that closed on October 31, 2017, this Solicitation amendment is being issued to address an oversight by SSC in its obligations to respond to a bidder inquiry that was submitted within the prescribe time. As such this solicitation R00016006/C is being issued to permit SSC to respond to the question asked and to afford bidders the required time to submit their bid response prior to the time identified for bid closing.

2. Response to bidder questions (Q&A)

Question 1:

Due to the fact that Requirement 1.2, and Annex B – Pricing Sheet Item 50 (where the number 50 was duplicated twice), and Item 51 mentions Uninterruptable Power Supply (UPS) Equipment, which is not networking equipment and there is no justification for including them on this RFQ, will SSC please delete these items from this Solicitation and tender them separately, so that SSC will be able to obtain more competition for these UPS?

Answer 1:

A correction to the numbering of line items has been made to the pricing sheet. SSC acknowledges that the inclusion of said UPS products to the list of deliverables for this requirement is one that could have been procured via a separate contracting instrument; however SSC reserves the right to procure its products from whatever contracting instrument best serves the specific circumstances. SSC also has an obligation to its clients and to ensure that the compliment of products being supplied and installed for the purpose of a complete solution must be supplied and coordinated by the successful incumbent. As such these products will not be stripped out of this procurement process.
