### QUESTIONS AND ANSWERS:

#### Question 15:

Section 2.1 – Definition of Bidder in SACC 2003 (2017-04-24) Standard Instructions - Goods or Services - Competitive Requirements:

The definition of "Bidder" as used in the above referenced SACC Manual clauses, excludes subcontractors and prevents a Systems Integrator (SI) and COTS vendor combination to bid. We believe that the experience of COTS subcontractors/partners should be taken into consideration and encouraged to provide the best solution and value to the Crown. We, as a global firm, work with a large eco-system of industry leading COTS providers, some of which develop Search and Rescue Mission Management Systems that the Crown would benefit from.

Where the Crown's requirements are as extensive as set out in the RFP, and the bidders are required to declare all software components, the proven experience of industry leading COTS solutions providers should be allowed. We therefore seek confirmation that the experiences of subcontractors of a Bidder and/or SI and COTS vendor combinations will be accepted as part of an RFP response for the mandatory and rated criteria evaluation.

#### Answer 15:

After review, Canada has decided to keep the RFP the same.

#### Question 16:

Canada has stated that only the bidder's experience and qualifications are eligible to meet the mandatory criteria outlined in the RFP. This approach is extremely unusual in a procurement of this nature. Canada has further stated that a Joint Venture is the only mechanism where a team's qualifications may be used to meet the mandatory requirements, despite the fact that joint ventures are highly improbable arrangements, requiring significant investment, complex legal structures and time to establish for a bid with such a short (and inflexible) duration bid period. It seems that Canada is intent on

eliminating Small and Medium Enterprise's (SME's) who on their own cannot meet the mandatory requirements but who may be entering into traditional Prime – Sub relationships. This approach seems to be contrary to all published policies on open and fair competitions, support for innovation and SME's and deriving the best value for Canada. Please explain the rationale and benefit to Canada of restricting the definition of the bidder as described in amendment 002?

**Answer 16:**

After review, Canada has decided to keep the RFP the same. The rationale of the definition of the Bidder as described in amendment 002 is because Canada does not have a contractual relationship with any sub-contractors that would require performance from them. With regards to a joint-venture, if applicable, please also see instructions on how to bid as a joint-venture in subsection 17 of 2003, Standard Instructions - Goods or Services - Competitive Requirements of the SACC manual, which is referenced in Part 2 of the bid solicitation.
