QUESTIONS AND ANSWERS

QUESTION 79

In Answer 67 Canada has indicated that transcripts and any required supporting documents would be acceptable to meet this requirement. The resources who meet these requirements have extensive experience in the industry, and as such, likely graduated over 20 years ago. In this time, resources may have lost copies of their degrees, either through error or accident. The processing time for a new Degree is extensive and is often over 2 months in length (significantly longer than the solicitation period), however, official transcripts can be awarded within less than a week. As such, would Canada also please allow for University transcripts to be accepted as sufficient educational evidence if accompanied by any necessary supporting documentation?

ANSWER 79

Answer 67 refers to an exception to certain educational requirements granted due to the Ontario public college strike. No other exceptions of this nature are granted. Canada will not change this requirement as requested.
