QUESTIONS AND ANSWERS

Question 6: Request for equals submitted for consideration

Answer 6: Equivalents noted are accepted and attached as a separate document.

Question 7: We wish to supply a price for the window film that is required for the exterior windows. Do you know if the window sizes are available?

Answer 7: Window measurements are not available.

Question 8: Several items specify supply and install and some items only specify install. Are there certain items that you are supplying? For example, flooring, soap dispensers, baseboard and mirrors?

Answer 8: All items should read "supply and install". RCMP will not be supplying any products for this project.

Question 9: We've had several questions from plumbing companies regarding installing fire dampers. The scope of work does not mention anything to do with the duct work, but answers pertaining to site visit questions states dampers where required. Just looking for clarification as to which ducts require dampers.

Answer 9: Dampers are required for all supply air ducts.

Question 10: Time line, is the January 15th, 2018 completion date still possible given that everything in the specifications is special order?

Answer 10: Completion date will be adjusted through change order based on delivery dates of special order items, if required.

Question 11: In the Specification, the General Contractor is responsible for storing and moving furniture. Is the intent the General Contractor GC has a storage trailer onsite?

Answer 11: Yes, but only for furniture, or non-protected materials.

Question 12: What is the fire rating in the mechanical room?

Answer 12: Fire rating for mechanical room is 1 hour.

Question 13: How many spaces can we disrupt at one time?

Answer 13: The building must remain operational. The contractor must attempt to minimize disruptions to the main office area and cell block to ensure continuity of service. Support spaces such as the gym and upstairs bathroom can be disrupted for longer periods.

Question 14: Is there better specifications on the door or hardware?

Answer 14: Door specifications contained within the scope.
