Solicitation Amendment No.002 is being issued to respond to questions from potential bidders.

Questions and Answers

1. Does the development of gender specific Info Ops (in operations) by a CAF member count as a project under Point Rated Criteria - B2? Example: digital radio programming to open communication with specific groups.

A: No, it does not meet the criteria for B2

2. Under Point Rated Criteria C1 and C3, do projects need to demonstrate work conducted across the 60 months? Example - Projects completed each year to show experience is concurrent with the present year?

A: Projects need to have been completed within the past 60 months

3. The proposed project schedule will be relatively short upon contract award which increases the risk that the deliverables identified in the SOW will not be completed by March 31, 2018. Given the scope of work and the compressed time frame, using a team based approach will ensure the work is completed by March 31, 2018. In addition, the Basis of Payment requires all team members to be listed. However, there is no team evaluation criteria specified. Will the Crown consider awarding points for team composition?

A: Although it is understood that a team approach might seem to be a better solution, it is felt that a single resource could also dedicate their time to this work. At this time we will not change the evaluation for team composition.

4. Is there a level of funding already determined for the Scope of Work? If so, approximately what is the limitation of expenditure?

A: MAXIMUM FUNDING

The maximum funding available for the Contract resulting from the bid solicitation is \$60,000.00 (Applicable Taxes extra).
