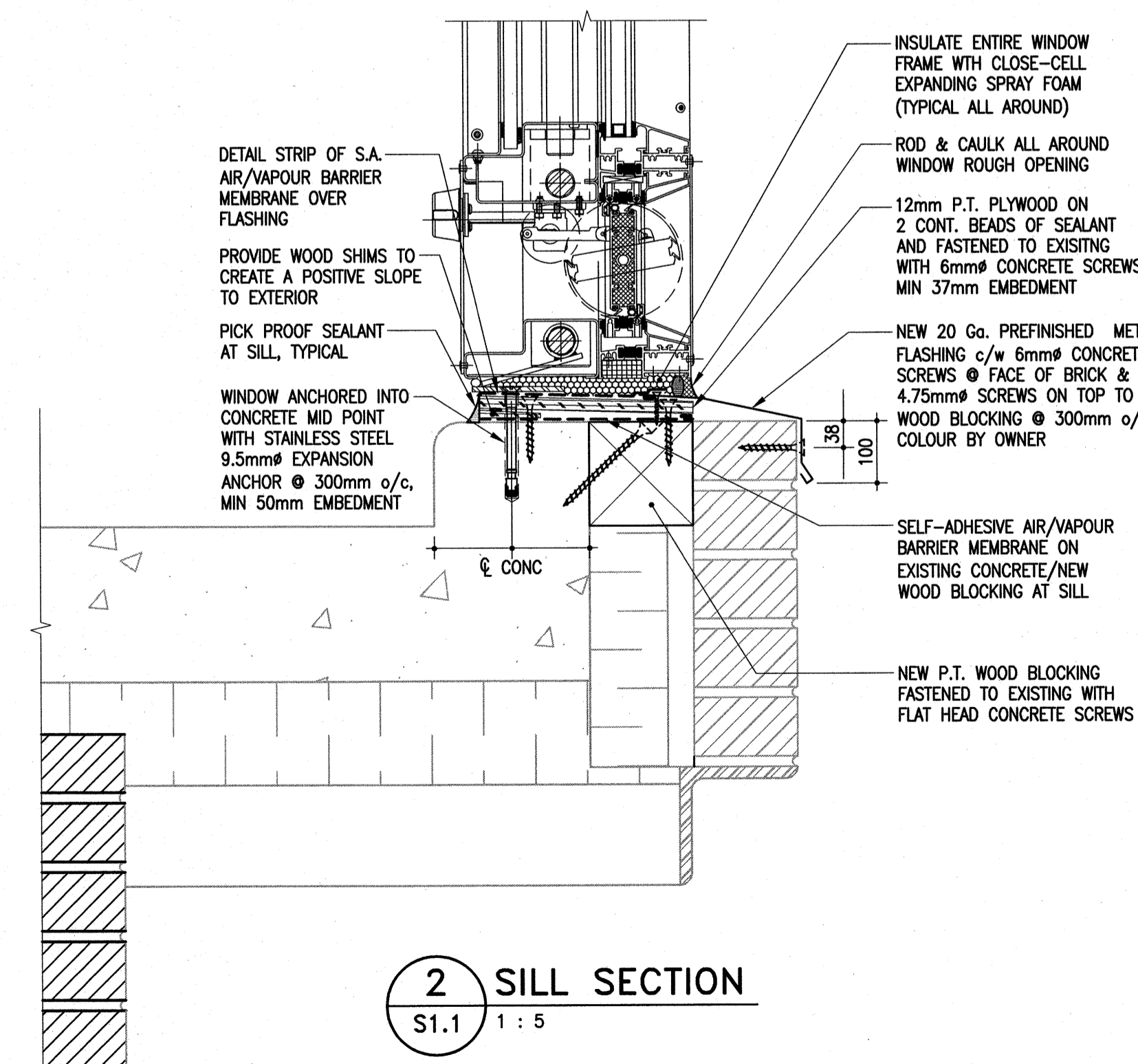
PARTIAL WALL ELEVATION

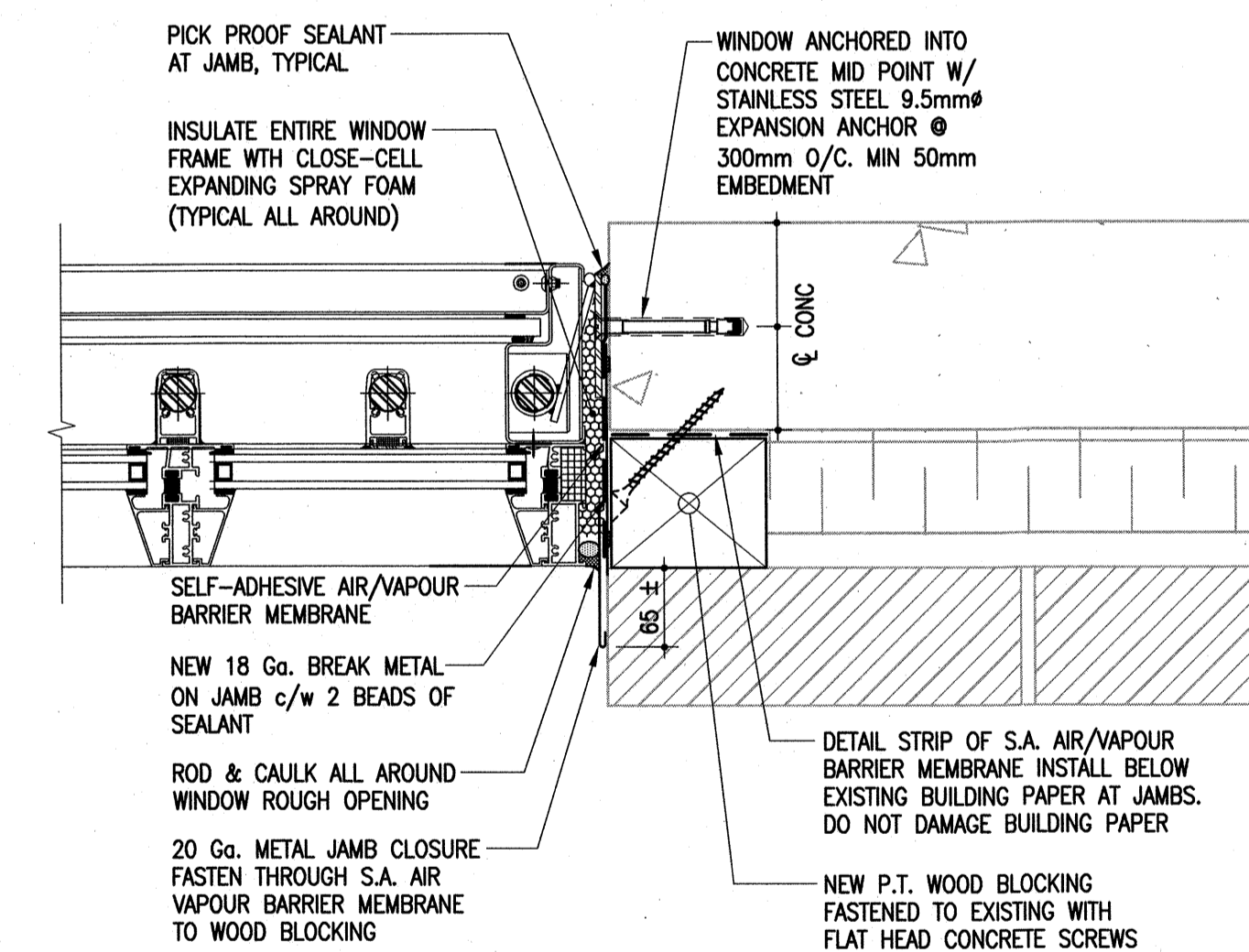
1 HEAD SECTION

GENERAL NOTES

- DO NOT SCALE DRAWINGS.
- DRAWINGS ARE BASED ON THE BEST AVAILABLE INFORMATION REGARDING THE EXISTING CONSTRUCTION. REVIEW ON SITE ALL RELEVANT EXISTING CONSTRUCTION WITH RESPECT TO ELEMENT SIZES AND CONFIGURATIONS AND VARIATIONS BETWEEN AREAS AND ADVISE ENGINEER OF ANY DISCREPANCIES.
- SITE MEASURE ALL WINDOW ROUGH OPENINGS PRIOR TO FABRICATION.
- PROVIDE WINDOW PERFORMANCE TESTING DATA TO AS PER SPECIFICATIONS, INCLUDING BUT NOT LIMITED TO, AIR LEAKAGE RESISTANCE, WATER PENETRATION RESISTANCE, AND UNIFORM LOAD DEFLECTION AND STRUCTURAL TESTING.
- PREPARE MOCK-UPS OF STAGES OF CONSTRUCTION AS PER SPECIFICATIONS. DO NOT PROCEED WITH WORK PRIOR TO REVIEW OF MOCK-UP STAGE AND ACCEPTANCE OF MOCK-UP AS MINIMUM STANDARD OF WORKMANSHIP.
- PROVIDE FULL SHOP DRAWINGS UNDER SASKATCHEWAN ENGINEER'S SEAL FOR WINDOWS INDICATING DESIGN CRITERIA, INCLUDING ALL DETENTION CRITERIA.
- ANCHOR WINDOWS INTO SOUND CONCRETE SUBSTRATE.
- TOOTH BRICK REPAIRS INTO EXISTING BRICK WORK WITH APPROPRIATE MORTAR. MASONRY WORK TO BE PERFORMED UNDER THE DIRECT SUPERVISION OF A JOURNEYMAN MASON.
- MOCK-UP OF MORTAR JOINTS TO BE PREPARED WITH REGARD TO JOINT TOOLING AND MORTAR COLOUR. SUBMIT RESULTS OF MORTAR TESTING CUBES, MEASURING COMPRESSIVE STRENGTH. SUBMIT RESULTS OF MORTAR AIR ENTRAINMENT TESTING, INDICATING THAT MORTAR AIR ENTRAINMENT IS BETWEEN 7% AND 11%.
