PART 1 - GENERAL INFORMATION

1.1 Introduction

The bid solicitation document is divided into six parts plus attachments and annexes as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Bidder Instructions: provides the instructions, clauses and conditions applicable to the bid solicitation;
- Part 3 Bid Preparation Instructions: provides Bidders with instructions on how to prepare their bid;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria that must be addressed in the bid, and the basis of selection;
- Part 5 Certifications and Additional Information: includes the certifications and additional information to be provided;
- Part 6 Security, and Other Requirements: includes specific requirements that must be addressed by Bidders; and
- Part 7 Resulting Contract Clauses: includes the clauses and conditions that will apply to any resulting contract.

The Annexes include the Statement of Work, the Basis of Payment, the Security Requirement Check List (SRCL); the Electronic Payment Instruments, the Federal Contractors Program for Employment Equity – Certification, and other annexes.

1.2 Summary

Department of National Defence, Maritime Forces Atlantic, has a requirement for Services to dismantle and remove the Southerly Halifax Narrow Trot Bay Mooring System. See Annex A – Statement of Work for more details.

The period for this contract will be from date of contract award to March 30th, 2018.

The requirement is subject to the provisions of the Canadian Free Trade Agreement on Internal Trade (CFTA), North American Free Trade Agreement (NAFTA), World Trade Organization Agreement on Government Procurement (WTO-AGP) and Canadian Free Trade Agreement (CFTA)

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Former Public Servant (to be completed by Bidder)

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPS, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. It does not include pensions payable pursuant to the *Canadian Forces Superannuation Act*, R.S., 1985, c. C-17, the *Defence Services Pension Continuation Act*, 1970, c. D-3, the *Royal Canadian Mounted Police Pension Continuation Act*, 1970, c. R-10, and the *Royal Canadian Mounted Police Superannuation Act*, R.S., 1985, c. R-11, the *Members of Parliament Retiring Allowances Act*, R.S., 1985, c. M-5, and that portion of pension payable to the *Canada Pension Plan Act*, R.S., 1985, c. C-8.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Nova Scotia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Title: Trot Buoy Mooring System

Objective

To dismantle and remove the Southerly Halifax Narrows Trot Buoy Mooring System.

2. Background

- 2.1 To have a contractor recover, remove, and dismantle the entire Department of National Defence (DND) Trot mooring system in the Southerly Halifax Narrows Harbour.
- 2.2 Contractor shall have, but is not limited to a crane, barge and other associated equipment that is capable of working in twenty (20) metres of water (63.5' – 69.5') with a tidal range of six (6') average to recover the entire DND Trot mooring system in Halifax Narrows Harbour. Contractor requires the capability to grapple for, winch and or lift the ground tackle to the surface.

3. Requirements
