This solicitation amendment is raised to:

- 1. Address the following questions submitted during the solicitation period; and
- 2. Amend the RFB.

1. QUESTIONS AND ANSWERS

- In the bid document the panel counts/widths do not match the drawing. Are we to quote our product based Q1: on the drawing and adjust your PDF list of panel types or only quote per your list?
- A1. Bidders should provide their bid in accordance with the floor plan. Item 3, Product Configuration has been amended to remove the quantities. See Amendments to the RFB below.
- Q2: The list is referring to a panel type with an upper fabric side 1 and upper accessory rail side 2, however, 99% of the panels on the drawing have upper accessory rails both sides. Can we correct that panel type count and add the double sided panel type?
- A2: The Panel Matrices in Annex C have been updated to account for the 42" panels which have accessory rails on both sides. See Amendments to the RFB below.
- Q3: Would it be possible to remove the Cat 1b items (pencil cup and legal paper tray)? As this causes a restriction for more suppliers to participate if one does not have these particular items on the Supply Arrangement.
- A3: The CRA requires all items specified in Annex C. This requirement remains unchanged.
- Q4: Will the shipping locations be able to accommodate a 53 foot trailer for the delivery of the goods? If not, what is the maximum truck length the location can accommodate?
- The shipping locations can accommodate up to a 42 foot trailer. A4:
- Q5: Could you please confirm if the locations have a loading dock?
- Yes, please refer to Table 8 Standard Finishes and Canada's Facilities to Accommodate the Delivery and A5: Certifications OF Annex A – Requirement and Basis of Payment.
- Q6: Could you please confirm if the locations have a service elevator?
- Yes, please refer to Table 8 Standard Finishes and Canada's Facilities to Accommodate the Delivery and A6: Certifications of Annex A – Requirement and Basis of Payment.
- Q7: in Area 3, there is only 13" between the panels of workstation # S1-626 and S1-627 and it should be 36-44" for fire code compliance. Are we to quote per the drawing, and then revise once the contract has been awarded with the local CRA contacts?
- A7: The Contractor must install in accordance with the floor plan outlined in Annex C. This requirement remains unchanged.
- Q8: There is no mention about electrical in the panels. Is any electrical required? Please advise.
- A8: As per "Product Descriptions" under Annex C, "All panels: Non-powered".

Q9: On page 14 of the RFB document refers to a panel matrix - Panel B is the only panel with an accessory element. However, looking at the drawings, a great majority of these panels will be coming with an accessory tile on both sides. Please confirm how many panels require an accessory rail. We counted a total of 20 42" wide panels with only 1 accessory element & 67 42" wide panels that have the accessory on both sides.
