Amendment # 3 is issued to answer potential bidder's questions.

Question #1:

Recital 2.3 of Annex A – Statement of Requirement. This recital states that both the MPLS and the VMLS must be fully assembled before shipping. Does this mean that you also want these units mounted to their tripods and magnetic mounts? If this is the case, it may lead to damage during shipping.

Answer #1:

No it does not mean the units should be mounted to their and magnetic mounts.

Question #2:

Recital 2.5 of Annex A – Statement of Requirements – Specifications page 7/15 – Number 8 – Magnetic Mount – For the purpose of greater clarity and increased functionality for the portable units, it should be stated that the MPLS must be designed and built to be mounted on a military vehicle with a magnetic mount

Answer #2:

Annex A, Spec 7/15 – Number 8 already states “Must be designed and built to be mounted on military vehicles with magnetic mount.”

Question #3:


Recital 2.5 of Annex A – Statement of Requirements – Specifications page 7/15 – Number 13 – Cone of Sound – are the 15 and 25 degrees respective requirements measured in total or from centre?

Answer #3:

The Cone of Sound should be measured from the center.

Question #4:

Recital 2.5 of Annex A – Statement of Requirements – Specifications page 7/15 – Number 14 – Directional - ``**Must broadcast at target, independent of the vehicle or tripod, and adjustable in pitch through an arc of 360 degrees**`` For Clarity, a circle is a full 360 degree arc which would mean to say that the system must be able to broadcast in a full circle. This is a bit unusual as we see this type of requirement in a fixed system that would be used in an industrial or institutional application and not for a vehicle mounted solution. Example of a 360 degree arc below. Does this particular statement of requirements stand, as is or will this be modified to suit the desired application for a vehicle mounted unit? Please specify if the 360 degree arc angle is on a horizontal plane (top view) or vertical plane (side view).



Answer #4:

We require to be able to broadcast 360 degrees by moving the system to point at a specific location as required. 360 degree arc is on a horizontal plane with the ability to be adjustability in pitch.

Question #5:

In recital 2.5 – Mandatory technical requirements Page 8 of 15 Configuration 2 VMLS States ``*the total weight must not exceed 15 kg (not Including internal batteries)*`` While Page 5 of 10 of the Mandatory Technical Performance requirement, specifically M15 for configuration 2 VMLS states ``*the weight must not exceed 15 kg (including internal batteries for operation)*``. For Configuration 1 MPLS, both specifications show the weight **including** internal batteries. Please confirm which is correct.

Answer #5:

Specifications on Page 8 of 15 are correct.

Here are the correct technical requirements as stated in Annex A Page 8 of 15 – Number 15.

Weight MUST not exceed in total weight:

Config 1 MPLS: 10 KG (including internal batteries required for operation)

Config 2 VLMS: 15 KG (not including internal batteries required for operation)

Question #6:

Based on the aforementioned point on the weight issue discrepancy, would DND be willing to allow for a maximum weight from 17.0kg to 17.5kg for configuration 2 VMLS?

Answer #6:

The requirement for Configuration 2 is as stated on Annex A Page 8 of 15 – Number 15.

Recital 3.3.2 of Annex A - Bi-weekly meetings is a term that is used quite often but does require clarity – Is the expectation for two meetings per week or one meeting every two weeks?

Answer #7:

One meeting every two weeks.

All other terms and conditions remain the same.
