BIDDER QUESTIONS

Question: Can you please clarify what is meant by “Red Iron” as noted in addendum #6 page 3, point 1? Does this mean that all exposed steel for the Pre-Eng building needs to be painted to the same colour as the room schedule (including girts)? In the spec section 13 34 19 part 2.5.1 it states all structural steel must be shop primed, but it does not say anything about painting it a specific colour. Our pre-eng building supplier has stated that painting the pre-eng steel is not typical on most of their jobs; if it is required, the costs to complete it will be quite significant too.

Answer: Interior steel shall only receive shop-prime painting per Specifications 13 34 19 Clause 2.5.1. Refer to DRAWINGS revision above.
