PART 1 - GENERAL INFORMATION

1.1 Security Requirements

1.2 Statement of Requirement

2.1 Standard Instructions, Clauses and Conditions

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is

eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in British Columbia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

STATEMENT OF REQUIREMENT

1. Title

Bullet Trap

2. Background

One of the most important elements in maintenance of firearms is the ability to test fire the firearms. This requires the use of a live fire range or the use of a bullet trap. A bullet trap aids in the stopping of bullets fired for a variety of testing purposes such as testing rate of fire.

3. Objective

To provide TEME's Weapons Technicians with the tools required to perform necessary maintenance on critical weapons in CFB Esquimalt's small arms fleet.

4. Scope

Canadian Armed Forces (CAF) Weapons Technicians perform maintenance on a variety of weapons, such as the C6 general purpose machine gun (GPMG). The C6 requires a bullet trap to facilitate gas regulator work. Adjustment and verification of the regulator must be done to achieve a prescribed rate of fire by a Weapons Technician. There is no way to utilize local ranges for C6 maintenance due to restrictions on firing such as caliber size, and rate of fire. In addition, the remoteness of local ranges without these restrictions makes it financially prohibitive to travel to them for testing purposes. As a result, a more localized bullet trap is required for CFB Esquimalt.

5. Mandatory Requirements

The bullet trap must fit within TEME's weapons workshop. Testing is NOT permitted outside this room.

	c) There is a wall corner (wall section) that is 4 feet inside the door that is centered with the door frame. This wall corner prevents straight entry into the workshop. The dimensions of the bullet trap must be small enough to navigate around this wall corner. DND can move an item into the shop at about a 60 degree angle from the workshop floor. This limits the dimensions to the ones specified in this SOW.			
	d) Bullet traps that come apart and re-assemble easily to accommodate these dimensions are acceptable.
