Amendment to the Solicitation 005

This amendment to the solicitation is raised to:

1. Provide answers to Bidders questions in relation to this Request for Proposal (RFP); and

1. Answers to Questions 18 and 19:

Question #18:

Regarding CM2 of Attachment 4.1: Although the change Canada made to CM2 in Amendment #1, Question #1 is understood, in order to allow for a more competitive process, and while still allowing Canada to assess a Bidder's corporate ability to quickly ramp up on a contract, we respectfully request that the requirement be revised to read:

In one (1) of the two (2) contracts provided in CM1, the Bidder must clearly demonstrate that it provided qualified resources, which contained the following:
a minimum of 5 resources within the initial 3consecutive month time period from the start of the contract or from the issuance of the initial Task Authorization against the contract within the last 60 months (as of bid closing date); and
the Bidder maintained these 5 resources for a minimum period of 6 consecutive months thereafter (see note below).

Given the nature of the work and experience required for this project, this small change will allow a greater number of otherwise qualified bidders to compete on this RFP.

Answer #18:

Canada has already considered the question and has decided that no changes will be made to CM2 for operational reasons.

Question #19:

Annex D – Non-Disclosure Agreement: Please confirm that signed copies of the Non-Disclosure Agreement in Annex D are not required at bid submission and that only the successful proponent will be required to submit the Agreements at contract award.
