AMENDMENT 001

This Amendment 001 is raised to respond to supplier inquiries and modify Annex "A".

Questions and Answers:

Q1) Part 1 1.1. Please confirm if they are or not security requirements.

A1) Per 6.1 of the Resulting Contract Clauses, there are no Security Requirements for the Contract.

Q2) Part 3 Bid preparation. Are you not requesting a technical section? , the evaluation procedures says in 4.1 (a) includes technical bid but you are not instructing that in Part 3 Bid preparation. What is the buying strategy? Lowest price?

A2) Per Part 3 – Bid Preparation Instructions only a Financial Bid and Certifications are required. Per 4.2 Basis of Selection: "A bid must comply with all requirements of the bid solicitation to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract."

Q3) Do we have to include in our prices, assembly and set up of the equipment on site and disposal of packing materials? Can you tell us if there is one or several points of delivery and what are the addresses please?

A3) Assembly of equipment is not necessary, therefore disposal of packing material is moot. There is only one point of delivery 75 Anson Ave, Astra, Ontario a vehicle with lift platform is a must, as there is no fork lift at this site.

Q4) The spin bike that we are planning to quote does not measure METS but the console measures ; time, distance, calories, RPM, level of resistance, watts and heart rate via chest strap. Will you consider the product if it does not measure METS?

A4) METS is not required. The proposed spin bike would be approved.

Q5) Our proposed product has speed in Km and cannot be changed to miles and it goes from 1-20 km/hr. will that be acceptable? 20 km/hr is equivalent to 12 mph. We do have a feature that has quick speed keys and quick elevation keys.

A5) As certain fitness protocols require a read out in MPH, this requirement must be met in order to be approved.

Q6) Our proposed elliptical does not have a USB jack 3.5 mm headphone jack, will you accept this? Would like to ask why you need the USB jack with 3.5 mm headphone jack.

A6) This requirement is standard on all of our current machines and allows patrons to charge music playing devices as well as listen to them while using the machinery. The proposed elliptical will not be approved.

Q7) Will you accept front mounted flywheels as well?

A7) Yes the bike will be accepted if it meets all other specifications.

Special Requirements:

1. Deliveries must be made directly to CFB Trenton, 75 Anson Ave, Astra, Ontario. Delivery must be supported by a vehicle with lift platform as no forklift is available on site. Packing slips or bill of lading are to be included with each delivery.

2. After a complete and thorough inspection, if products/articles are found incomplete or deviate from the original order, the supplier will be notified and adjustments are to be carried out within 24 hours of notification.
