The above mentioned Request for Proposal (RFP) is hereby amended to answer questions received.

For Priority Technology 2 (PT- 2): Breadboard of Next Generation Coastal and Inland Water Color Imaging Spectrometer

Question 1:

Section 8.1 clearly states that coolers for the GFE FPAs are not included. It is also clear that if coolers are required for this project they are to be listed as a separate item in the financial bid, and their cost is not included in funding available for this project. However, there is no mention of dewars for the GFE FPAs. Do the GFE FPAs come with dewars that are capable of being cooled to the manufacturer's specified temperature? If the FPAs do not have dewars then are the dewars considered to be already apart of what is referred to as "coolers" in the RFP and therefore are treated as a separate item in the bid? If not, then should we consider dewars for the FPAs a necessary equipment procurement required to be undertaken within the funding available for this project?

Answer 1:

The cost for the coolers (e.g. dewars) has been taken into account in the total funding allocated to the PT-2 of the RFP. The bidder shall propose procurement of the coolers for the FPAs and list the cost as a separate item in the financial bid if they do not have them in their facility. In the RFP, it is clearly stated that "Coolers for the GFE FPAs are not included." GFE FPAs will not come with dewars.

Question 2:

Under item [FPA-003] in section 8.1, the GFE FPAs provided in this project are required to be cooled to operate at the required temperature specified by the manufacturer. What is the manufacturer specified temperature for the MCT FPAs from Teledyne?

Answer 2:

The GFE FPAs from Teledyne are under US ITAR restriction. No detailed technical information can be released at the moment. Please use the common operating temperature for Mercury Cadmium Telluride (MCT) FPAs.
