This amendment for the Borden Area is being raised to answer questions to date.

Q1. Will gasoline cube trucks (16') fulfill the requirement under 2.1.3 vehicle category list – cube truck 16' instead of diesel?

A1. Yes.

Q2. Do we need to quote every car class in order to receive a 'responsive bid'?

A2. Yes.

Q3. What is your formula for pricing in order to determine who the awarded bidder is?

A3. See Part 4 Evaluation.

Q4. Will you grade each vehicle class category individual or is this the aggregate total for year one. (Award by car class?).

A4. Aggregate total.

Q5. Do you comprise the aggregate total of year one, two & three for pricing?

A5. Yes.

Q6. What happens if a bidder is the lowest compliant bidder in year one, but not all three years. Will you award each year separately?

A6. No.

Q7. Is \$2 million in liability mandatory to be awarded this bid?

A7. Yes.

Q8. What is the minimum age of drivers that will be driving these vehicles?

A8. 18.

Q9. Are you able to break down each car class usage and which months they will be rented for?

A9. No.

Q10. Do all vehicles require snow tires?

A10. No.

Q11. Is "best price" the sole determining factor for award or will you base award on vendor who provides the "best value" (taking it consideration price, available fleet size, # of service locations, history of service, etc.)?

A11. Lowest price meeting mandatory.

Q12. Are rates locked in for the full term of the contract or do you permit rate escalations before exercising each Option Period?

A12. Basis of Payment has a breakdown for each year. All prices are firm.

Q13. Are you able to provide a template to add misc. services pricing?

A13. There are no miscellaneous pricing items.

Q14. What is the minimum detail you require for reporting?

A14. Breakdown of quantity and cost per category.

Q15. Will you work with the awarded provider to determine mutually acceptable process and dates to submit the needed reports?

A15. Yes.

Q16. When do charges cease? At time of accident or at time of contractor being notified?

A16. Time of accident.

Q17. What is the average km's driven per month?

A17. Undetermined.

Q18. Who is responsible for damage to vehicles? Can we charge different CDW rates for different vehicle classes? Will you accept a deductible? If so, how much will you accept?

A18. See Annex A. No CDW and no deductible applies.

Q19. What is your process to inform contractor a vehicle is being returned and the day charges should stop?

A19. Fax or email.

Q20. Will you allow a vehicle delivery fee to be charged on multiple vehicle requests?

A20. No.

Q21. Define expectations of "promptly"?

A21. Same day.

Q22. What is the responsibility/duties of the renter to ensure the vehicle is maintained properly?

A22. All maintenance is the responsibility of the contractor, including oil changes.

Q23. Will KM's used be given?

A23. Yes, upon request.

Q24. Will contractor sign a master rental agreement?

A24. Not applicable.

Q25. What is the expected turnaround time on a delivery?

A25. See Annex A.

Q26. Will DND be responsible for 407 and tickets?

A26. DND will pay tickets. 407 charges will be charged to the contractor but can be reimbursed by 407ETR with a DND form.

Q27. How will call-ups be made?

A27. See 6.8 Call up procedures. For each call-up, the user will search the SO's for the category of vehicle and contact the lowest price supplier for that category. Multiple call-ups may be made for requirements of multiple vehicle categories.
