1. An Advance Contract Award Notice (ACAN) allows departments and agencies to post a notice, for no less than fifteen calendar days, indicating to the supplier community that it intends to award a good, service or construction contract to a pre-identified contractor. If no other supplier submits, on or before the closing date, a statement of capabilities that meets the requirements set out in the ACAN, the competitive requirements of the government's contracting policy have been met. Following notification to suppliers not successful in demonstrating that their statement of capabilities meets the requirements set out in the ACAN, the contract may then be awarded using the Treasury Board's electronic bidding authorities.

If other potential suppliers submit statements of capabilities during the fifteen calendar day posting period, and meet the requirements set out in the ACAN the department or agency must proceed to a full tendering process on either government's electronic tendering service or through traditional means, in order to award the contract.

- Autoclave 20 Inch Century Vac Elec
- Autoclave Lab 250 Vac Elec

3. Criteria for assessment of the Statement of Capabilities (minimal essential requirements)

- Must be an authorized agency authorized to represent, and carry out maintenance on the Steris manufactured equipment including products under the brand names AMSCO, FINN AQUA and HAMO.
- 4. Justification for the Pre-Identified Supplier
 - Steris Canada Inc is the original equipment manufacturer for the National Research Council Glassware Washer and the two Autoclaves and is the

only known supplier that can address the systems maintenance requirements.

- 5. Period of the proposed contract or delivery date
 - The requirements for completion of the project is no later than March 31st, 2021
- 6. This ACAN contract serves for the first year of the contract at \$37,153.84, the second year at \$37,896.91 and the third year at \$38,275.88 for a grand total of \$113,326.63
