3. QUESTIONS AND ANSWERS

Q.01: In Category 1, there are 60w Typical D panels. Can you please confirm if we can supply two 30" wide panels instead on one 60" wide panel?

A.01: Panels must be 60" wide to avoid having multiple breaks/lines in stations to have a more uniform look.

Q.02: In Category 1, there are 60w Typical E panels. Can you please confirm if we can supply two 30" wide panels instead on one 60" wide panel?

A.02: Panels must be 60" wide to avoid having multiple breaks/lines in stations to have a more uniform look.

Q.03: Is the intent to award a contract to one supplier for all categories or is the intent to award based on lowest cost per category which could result in more than one contract?

A.03: The intent is to award one or multiple contracts based on the lowest cost per category identified in the RFB.

Q.04: Is it mandatory to submit pricing for all categories including category 6 to be deemed compliant?

A.04: No, it is not mandatory to submit pricing for all categories to be deemed compliant.
