QA69	Regarding answer 22 in amendment #002, it is our understanding that the consultant is required to produce documentation and contract administration for the soil remediation. Does this include on site verification and direction by the consultants?	No site verification is required for soils remediation. Site verification of soils remediation will be completed by the CM's testing and inspection specialist.
QA70	Regarding amendment #003, to QA37 No cash allowance will be applied. Please clarify that the \$6.5 million construction budget will include costs for the following; <ul style="list-style-type: none">- Site remediation and demolition.- Supply and installation of BCC.- Fire suppression and emergency generator.- Relocation of the existing communications tower from existing detachment.	The \$6.5M budget includes all construction and fit up costs including the items noted within this question. The only exception to the \$6.5M budget are the CM's fees.
QA71	Are the consultants responsible for the design of the infrastructure wiring to support LAN systems, security and CCTV?	Yes the consultants are responsible for the design of the infrastructure wiring to support LAN systems, security and CCTV.
