## **PART 1 - GENERAL INFORMATION**

### **1.1 Requirement**

The requirement is detailed under Article 6.1 of the resulting contract clauses.

### **1.2 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.3 Trade Agreements**

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA) and the Canadian Free Trade Agreement (CFTA).

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

### **2.2 Submission of Bids**

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

### **2.3 Enquiries - Bid Solicitation**

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

### **2.4 Applicable Laws**

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## **PART 3 - BID PREPARATION INSTRUCTIONS**

### **3.1 Bid Preparation Instructions**

Canada requests that Bidders provide their bid in separately bound sections as follows:

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

## ANNEX "A" - REQUIREMENT

### 1 Scope

The Department of National Defence (DND), 8 Air Maintenance Squadron (EMS), Engine Bay 3 hanger located at Canadian Forces Base Trenton (8 Wing) Ontario, conducts maintenance on C-130 Propellers. During the maintenance performed, there is a requirement to pressurize the system which produces a hydraulic mist that must be captured from the breathable air within the shop work area. EMS requires 3 portable oil mist collectors (Lev-Co model 02-065 or equivalent).

### 2 Background

The Royal Canadian Air Force (RCAF) is a vast organization, conducting a wide variety of operations in Canada and all over the world. This requires an extensive network of equipment and support, which are pushed to the limits to extract the most out of available resources.

In order to operate safely and effectively, the RCAF must comply with various airworthiness requirements of the *Aeronautics Act* when operating and maintaining aircraft and equipment. In the context of maintenance, this has led to the development of an approved maintenance program to ensure proper accordance.

Part of this program includes preventive maintenance, which requires regular inspection of aircraft and parts that undergo multiple stresses during operations. Many of these inspections include a visual inspection of the parts to verify for excessive wear and cracks. Complete teardowns and re-builds of the propeller and functional checks are necessary.

#### **Portable oil mist collector (Lev-co model 02-065 or equivalent)**

At a minimum, the portable oil mist collector must possess the following features:

- 5 hp motor 208-230V/460V/3/
- Variable frequency drive for the motor
- Hood with damper
- Carbon filter holder
- Wall bracket
- Hose clamps
- Flame retardant hose for extraction arms
- Minimum airflow: 2,400 CFM
- 10 foot flexible arm
- 2 Washable filters, with a minimum life of 5 years

### 3 Data

The Contractor must provide, in English, a complete and current user documentation including all technical reference manuals and user and maintenance guides of the original equipment manufacturer in hard copy format. If there are French language documents that already exist for this system, they must be provided.

### 4 Support

The Contractor must provide a representative to provide initial operational instruction at DND's site and within 2 weeks of Portable Mist Collectors receipt.

The Contractor must provide assistance with technical queries, on working days, by telephone within one working day of query receipt.
