Amendment 002 has been raised to publish all answers to questions received to-date.

A. QUESTIONS AND ANSWERS

- Q2.** 4.1.2.3 – Data Validation Testing - Upon the successful completion of the evaluation process described in the RFSO, can you please advise what the anticipated timing of the Data Evaluation Tests would be? When (approximately) would the testing phase of the desktop units occur?
- A2.** As per **PART 4 – EVALUATION PROCEDURES AND BASIS OF SELECTION** of the RFSO, section 4.1.2.3, the instrument must be made available within 15 calendar days after notification of compliant offer. It is expected that the tests will take 5 to 10 working days from start of testing.
- Q3.** Attachment 1 to Part 4 – Section B of Attachment 1 to Part 4 of the RFSO, identifies section 3.20 as the Mandatory Technical Criteria and it does not identify 3.21 as Mandatory Technical Criteria, but within Annex A of the SOW the entire 3.0 Instruments requirements are identified as mandatory. Please clarify.
- A3.** Section B of Attachment 1 to Part 4 are the mandatory technical evaluation criteria against which the offers will be evaluated. The offeror must demonstrate in its offer that it meets all of the mandatory technical evaluation criteria listed in Section B of Attachment 1 to Part 4, including the drugs and explosives that can be detected by the instrument (Section 3.20). As per the last paragraph before Section A of the Attachment 1 to part 4, regardless of the information provided in Section B, work must be done in accordance with Annex A. The detection limits mentioned in Section 3.21 of Annex A will be tested in the data validation testing.
- Q4.** Are the narcotics substance limits specified in section 3.21 requirements, guidelines, or targets? The limits identified in Section 3.21 of the Statement of Work are much more aggressive than industry standard for these substances.
- A4.** The detection limits specified in section 3.21 are mandatory requirements.
- Q5.** We have a major concern with the amendment that was issued today, specifically the changes in B2. Our [model], which has been tested and approved by regulators like the TSA, ECAC, Transport Canada etc. and is currently in use worldwide, does NOT use a radioactive source. NOT using a radioactive source is better for customers as it eliminates reporting, relocating and disposal requirements associated with radioactive sources. Please modify this response to strike this language “with a radioactive ionization source” to permit either type of source (radioactive or non-radioactive) to be used. If Canada does not want to use a radioactive source, the language should be changed to “with a non-radioactive ionization source”. Please advise, if this language does not change [we] will be prevented from being able to submit a compliant response.
- A5.** Canada has reviewed your request, and the requirement remains unchanged.
