This solicitation amendment is to promulgate the following:

- 1) Inform interested parties to request from the Contracting Authority the drawings and Environmental Reports for the CCGS W.E. RICKER by email request.
- 2) Provide responses to questions received from potential vendors.

Questions and Answers:

Q1) Is the artificial reef society going to be a bidder for this project? If so would that not be a conflict of interest as they are supplying the description of items to be removed.

A1) No, the Artificial Reef Society will not be bidding, they will give CCG the remediation work to be completed and will take on all aspects of the sinking of the ship.

Q2) During the walk thru it seemed that CC staff was still removing things, when will they be done so another walk thru can be organized.

A2) The removal by CCG staff has been done.

Q3) Is Canada giving this vessel to ARSBC upon completion for free or will CCGC remain the owner after it has been sunk.

A3) The ship will not be given to anyone, the CCGS will remain the owner of former W.E. Ricker at all times.

Q4) I would like to ask again May the vessel be sold as is.

A4) No, the ship will not be sold 'as is'.
