Question 1 - Please clarify location of the disposal area.

Answer 1 - Disposal area is located on site and is identified on Sht. 2 of 3 New Work by text "On Site Disposal Area." Note that there was an error on the plan and it has been corrected by the attached drawing. It is anticipated that the contractor will use existing on site stockpile material to berm and contain material removed from the harbour bottom to allow for toe in of armour.

Note environmental section 01 35 44 1.6 Disposal of Dredged/Excavated Material .1 should read "material will be disposed of on the Lower Sandy Point Small Craft Harbour property. The dredged material will be placed within the area identified by the plan Sheet 2 of 3 – on site disposal area."

Question 2 - Environmental section 01 35 44 1.9.7 Water Quality, please clarify who is to provide the water quality monitoring plan and who can sample.

Answer 2 - Water quality monitoring plan to be developed by a qualified environmental professional as provided by the Contractor. For clarification purposes the contractor can choose one of the following options for sampling: a) either the qualified environmental consultant can complete sampling on behalf of the contractor or b) the contractor can have the qualified environmental professional train one of the contractor's staff members to properly sample.

Question 3 - When was the sounding survey completed?

Answer 3 - November 2016 and processed January 2017
