QUESTIONS AND ANSWERS

- Q1: Asbestos Awareness training- can you clarify what this training is?
A1: Asbestos Awareness Training is not required as part of the Request for Standing Offer (RFSO), however Hazardous Material Awareness Training is required.
- Q2: Page count and CV's - We assume there are at least 4 CVs requested for our technical specialists, however for the other project team we need a minimum of 15 and maximum of 20. Can the additional 15 project staff CVs be added to an appendices perhaps? Or if not can we have additional pages to cover the CVs? Otherwise these CVs will consume a considerable amount of our maximum page allocation.
A2: No additional pages will be added or the CV added to the appendices. The bidder should be concise and to the point in providing CVs to optimize the information in the provided page count.
- Q3: Page 10 (D) – it asks for completion dates for the assignment of resources? Is that a typo perhaps?
A3: The bullet will be modified to read “(d) the assignment of the resources
- Q4: Proof of Ozone Depletion Awareness Training – please clarify what this training is etc.
A4: The Offeror is required to show that the proposed team members have the appropriate training in providing the required services which includes Ozone Depletion Awareness. Training can be acquired from a number of different training options which may include internal/external training, regulatory training, work experience training etc.
- Q5: Given the timing of the RFP (completion over the holidays/ vacations) - we may need extra time to gather our training documentation and other information. Would a 2 week extension be possible?
A5: No, the submission deadline is January 23, 2018.

By submission of its tender, the Tenderer confirms that it has read and understands the requirements expressed in all addenda and has included all costs of these requirements in its Total Tender Amount.
