Solicitation Amendment No. 001 is being issued to address the following Questions & Answer:

The questions pertain to the actual flooring required, and the duration of the rental.

Q1) Are you looking for pricing to rent or purchase this flooring; or both?

A1) We are looking for pricing to purchase this flooring. We do not want to rent the flooring.

Q2) Will this product be installed in a permanent location, or will you need the ability to move it around once we've installed it for you the first time?

A2) We will require the ability to install the flooring ourselves and to move the floor around as required. The flooring will be reused on multiple exercises and deployments as required.

Q3) We have two different flooring types available depending on your specific needs. We have a lay down flooring that follows the grade of the ground and includes cable trays for cords, etc. This product is called XXXXXX.

The second type of flooring is a raised flooring that sits a minimum of 6" off the ground and cables can be run underneath it. This type of floor is used to create a level surface inside a tent if needed, or tents can be mounted directly on top of the floor. This product is called XXXXXX.

A3) Flooring required is lay down flooring that follows the grade of the ground and includes cable trays for cords etc
