This amendment is being raised to respond to questions submitted in response to solicitation 5P201-17-5112/A:

## QUESTIONS AND ANSWERS

Q12. Is the successful proponent prohibited from competing to procure the actual work? Ie can the Construction Manager (CM) also self-perform the masonry work?

A12. Yes, the CM can perform work. The CM must be an agreed qualified trade and is invited to submit pricing. The tender process for this package is managed by the Consultant and Project Manager. Overall management of the implementation of the work remains a CM responsibility. See Terms of Reference Section PD 2.3 D 2.4.

Q13. Further to Appendix B - Basis of Payment item 1.a).2 - Does the fixed fee include the salaries of all staff employed by the CM that are required to complete the work, ie 3 superintendents, heritage coordinator, Cost estimator, safety, Project manager, etc?

A13. Yes, CM fee is to cover costs of CM team members throughout the project delivery.
