Amendment 003 is raised for the following:

Question 4 In reference to Amendment 002 -response to Q2; recommendation for your consideration - unit rate to drill if obstruction is encounter, Unit rate to supply and install concrete to fill pipe pile if drilling is required, Unit rate to mob/demob drilling equipment.

Answer 4 Proceed based on amendment #2 drilling and additional fill concrete to be incidental to the work.

Question 5 Please provide details on the scour slab, reinforcing steel and strength of concrete

Answer 5 Scour pad slabs are approximately 305mm thick, reinforcing consists of a top and bottom mats with each mat containing a row of 15 m bars at 305 centres and a row of 20m bars at 305 centers. The actual concrete strength is unknown however the design strength was minimum of 4000 psi or 30MPa.

Question 6 To perform the work from a land base operation please note that road restrictions will be in effect early March therefore, equipment would need to be mobilized prior to March road restriction and would remain on site until they are lifted in Mid May. Would this be a problem?

Answer 6 The road from highway 101 to the Digby town limit and from the Digby town limit to the Digby Ferry Terminal is typically exempt from spring weight restrictions. Potential bidders should consult with the Nova Scotia Dept. of Transportation and Renewal regarding their specific equipment mobilization and demobilization requirements and price the work accordingly.

All other terms and conditions remain the same.
