This reason for this amendment is to advise all potential bidders of the questions and answers pertaining to this Request for Proposals.

Question 1: What is the likely start date?

Answer 1: April 1st, 2018.

Question 2: What is the budget structure? Will it be hourly or project based?

Answer 2: All payments under this mandate will be made based on approved Task Authorizations (7.1.2 of the RFP) and in accordance with Annex "B" Basis of Payment in the RFP. Prospective suppliers need only submit hourly rates for the two key categories of service and the two blended rate categories.

Question 3: Do both the examples required need to be national (Canadian) or can they be international in focus?

Answer 3: As one must meet the definition of national as stated in the RFP, then at least one of the two campaigns must be national (Canadian).

Question 4: 10 page proposal, double sided or single sided?

Answer 4: Single sided.

Question 5: Does the USB need to have creative samples and a soft copy of the technical bid or just creative samples?

Answer 5: Just the creative samples.
