Amendment #5 is being issued in order to amend the tender, and respond to Questions PART 2 as follows:

THE FOLLOWING CHANGES IN THE TENDER DOCUMENTS ARE EFFECTIVE IMMEDIATELY.

1) The closing date of this tender is extended to January 18th, 2018, at 2:00 EST

Questions and Answer Part 2

Q1) Is an ACAD drawing available to share for the parking lot grading showing both existing grades, proposed grades and test pit locations?

A1) ACAD drawing will not be released to bidders during tender. Reference C100 and C101 for requested information and bid as per contract documents.

Q2) Is there a preferred limit for site protection fencing or is it only required at connections to the existing roads?

A2) Fence the entire site to keep the wildlife out of the construction area, and construction personnel and equipment out of wildlife habitat. Fence the perimeter identified as “extent of site” on drawings.

Q3) Can the existing topsoil be stripped, stockpiled and re-used?

A3) Import new topsoil to site. Existing topsoil is not of sufficient quality to be stripped, stockpile and re-used and must be removed.

Q4) Are there grades available for the proposed storm structures?

A4) Grades for the proposed storm structures are identified on drawing C101. Bid as per contract documents.

Q5) Can excess fill and rock remain on the RCMP property?

A5) No, all excess fill and rock is to be removed from site. The only exception is the boulders that are to be stockpiled (reference AD101 note 28 and L100 note 20).

- Q6) Drawing E1 detail 7/E1, could someone look into this detail as visually with the rock I do not think this will be done , also the depth of the footing is 2440mm but at the bottom right it states the footing is 600 x 600 x 600mm, could it be clarified please.
- A6) Detail 7/E1 indicates that it will be the responsibility of the contractor to provide sealed engineered shop drawings, as such detail 7/E1 shows general intent only. The expectation is that a variation of this detail will be implemented based on the design the contractors engineer provides.
