

Amendment 002 – January 16, 2018

This Amendment 002 is raised to make the following changes to the RFP:

1. At Part 1, Section 5 – Instructions for Submitting a Proposal, Article 5.2.1 is deleted in its entirety and replaced with the following:

"5.2.1 The first file ("File 1") must include the technical component of the Proposal ("Technical Proposal") that should consist of a fully detailed response to the requirements as described in Part IV- Technical Requirements of this RFP ("Requirements"), in the same order as the Requirements are listed. The first file ("File 1") must also include completed Forms A to D."

2. At Part 1, Section 5 – Instructions for Submitting a Proposal, Article 5.2.2 is deleted in its entirety and replaced with the following:

"5.2.2 The second file ("File 2") must include the Price Proposal ("Price Proposal"), which must consist of a fully completed Form E – Price Proposal Form."

3. At Part IV, Section 1 Mandatory Requirements, M2 is deleted in its entirety and replaced with the following:

4. At Part V, Appendix B, Section 2 – Project Description, Financial Operation Stream, , page 31, Article 4, the following changes apply:
