PART 1 - GENERAL INFORMATION

1.1 Statement of Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid so

1.3 Trade Agreements

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 10 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must

be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Alberta.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

ANNEX "A"

STATEMENT OF REQUIREMENT

General Description:

This statement of requirement addresses the requirement to supply new Road Hold signage for future installation on the 4 Wing Cold Lake airfield. Installation will be completed by DND personnel.

Background:

In accordance with TP312 (5th edition) Aerodrome Standards and Recommend Practices, wherever an airfield road for vehicular traffic intersects with a taxiway or runway, a combination of stop sign and instruction sign is required to convey specific information to the driver. As the existing airfield signage does not conform to the current aerodrome standards with respect to location, frangibility and information conveyed, it was raised as a deficiency observation during the last airfield audit in 2016.

Specifics:

The Department of National Defense (DND) has a requirement for fifteen (15) Road Hold Signs for the 4 Wing Cold Lake airfield. The requirement for this work is to supply all the material that will be mounted above the fifteen pairs of pre-positioned screw-in anchors (see attached drawing L-C252-0201/80-SK1).

The required material for each of the fifteen signs consists of the following:

- One (1) 610mm high by 2133mm wide by 4mm thick (minimum), non-illuminated aluminum sign, with back-mounted uni-strut mounting braces, and the unobstructed front side displaying the required signage (see drawing and Annex C) in adhesive retroreflective vinyl sheeting (3M Diamond grade or equivalent). The colours of the 'STOP' and 'FOD Check' portions of the sign sheeting must be white text (3M code 4090) over red background (3M code 4092), while the 'instruction' portion of the sign must be black text over yellow background (3M code 4091). All text must be a sans-serif font.
- Eight (8), 51mm uni-strut pipe clamps (comes with mounting hardware) for attaching the sign to the legs.
- Four (4) 1500mm long by 51mm diameter aluminum sign legs, threaded at both ends for mounting flanges and included caps. The legs must be frangible at 50mm or less from the transition plate or must be supplied with equivalent frangible couplings c/w mounting hardware.
- Four (4) mounting flanges (plain finish) c/w mounting hardware to transition plates.
- One (1) 2134mm long (minimum) by 6mm thick "C channel" pre-drilled hot dipped galvanized steel transition plate (c/w mounting hardware), as shown on attached drawing to mount on the screw-in anchor top plates.

A check print of the sign legends showing colours, text size, and font must be provided to, and accepted by the DND prior to final production of the signs.

If the supporting documentation referenced above has not been provided at bid closing, the Contracting Authority will notify the Bidder that they must provide supporting documentation within two (2) business days following notification. Failure to comply with the request of the Contracting Authority within that time period, will deem the bid non-responsive and the bid will be given no further consideration.
5. Bidders must address any concerns with the performance specifications in written detail to the Contracting Authority before bid closing as outlined in the Request for Proposal (RFP) document.
6. Failure to meet each mandatory performance specification will result in the bid being deemed non-responsive, and be given no further consideration.

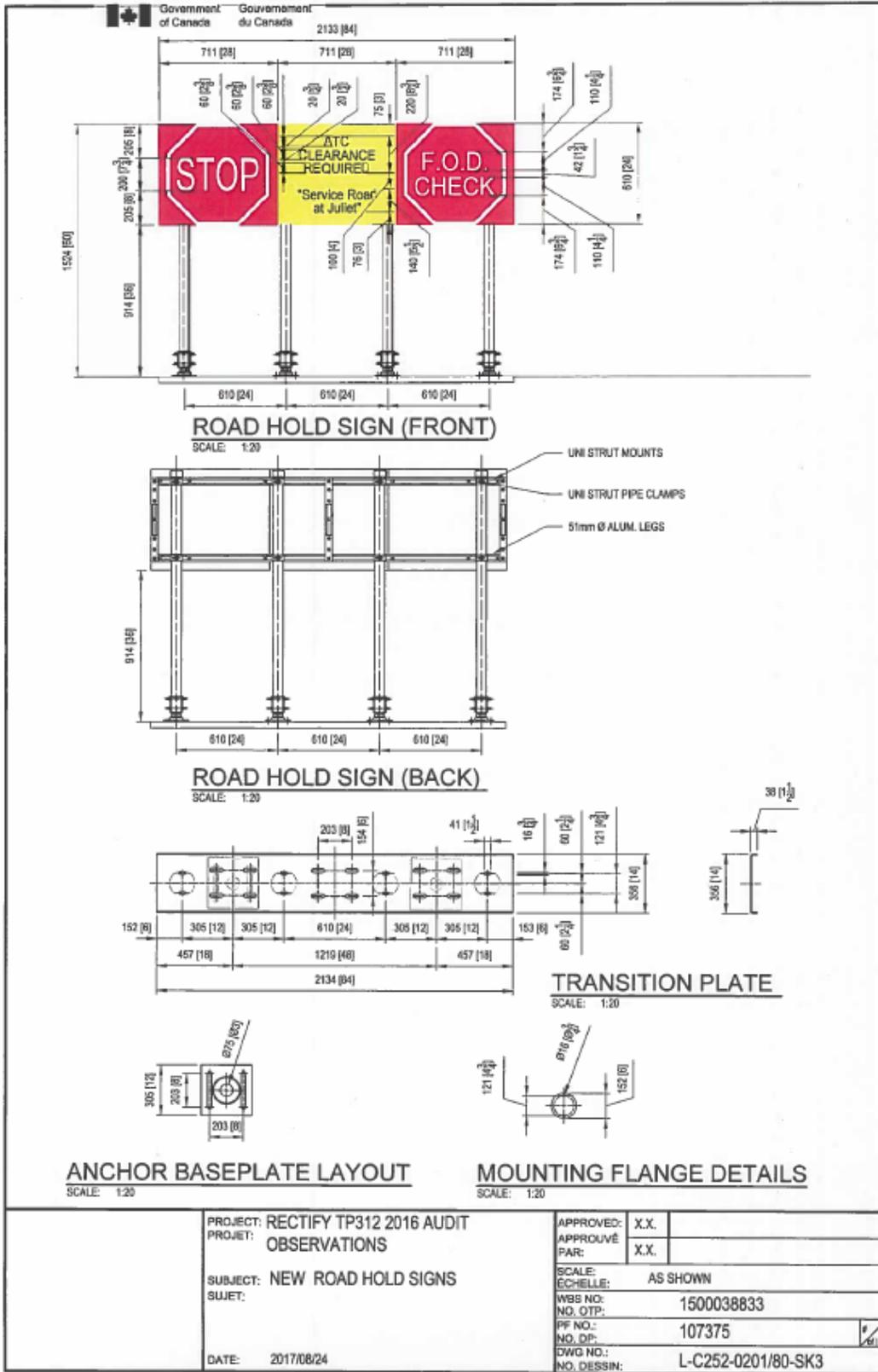
