Fitness Equipment

- Q1. At the head of Annex A it states, "All equipment must include - Delivery to the detachment and Installation". Jasper does not require "installation" as it is receiving only bumper plates. Bassano and Crowsnest Pass are each to receive a rowing machine. To unpack and set up is about 10 minutes only per machine. Is it necessary to do an installation in these locations? If it is not necessary, at what is the dividing line between necessary and unnecessary?
- A1. Yes, if a detachment is getting equipment that is not assembled, like bumper plates they could just be shipped.
- Q2. Can the equipment be assembled, palletized and shipped to any/ various locations? This would only require the unloading and moving of the piece to the desired area within the detachment by members of the detachment. Obviously heavier and more complicated pieces would require onsite assembly and set up.
- A2. Yes if the equipment can be pre-assembled, palletized and shipped that would be acceptable (like a rower). However all larger pieces, heavier pieces MUST be delivered and assembled on site (all cardio besides rowers, squat racks, functional trainers, etc). Our employees do not have the time or expertise to do so.
- Q3. Will orders for equipment be placed at one time - it would allow for efficiencies in shipping/delivery if locations close to one another were served at the same time.
- A3. Yes all orders will be placed at the same time once contract is awarded.
- Q4. There appears to be a height restriction on the Functional Trainer (Item 1, page 14/15) of 93 inches. However, there is no height restriction on the Multi/Half Rack. If there are no minimum specification requirements on the rack, can the minimum spec on the Functional Trainer be considered for the same? If a spec needs to be stated, a request for maximum height be changed to 95.5cm.
- A4. Yes height restriction for the Half Rack would be considered the same as the Functional Trainer
- Q5. In regards to strength training equipment specifications (Page 14) and throughout, there is a minimum spec for bolts (Grade 5 Zinc). Many manufacturers do not use the same verbiage or even mention the bolts. Many manufacturers use 'commercial grade hardware' when referring to fasteners. Can potential bidders still bid with commercial grade fasteners?
- A5. Yes commercial grade fasteners are acceptable.
- Q6. Clarification on Item 2, Page 16. The item states Half Rack/Multi Rack. Please clarify if you are referring to 1) Half Rack Only, 2) Multi Rack Only or 3) Half Rack/Multi Rack Combo (2 in 1)?
- A6. Half Rack.
- Q7. Clarification on Item 9, Page 16 – Olympic Bumper Plates. The description and sizes of plates do not reflect the makeup or sizes offered for Bumper Plates. Can you please confirm this should be Bumper Plates. If they are intended to be bumper plates, can you also confirm the sizes needed.

- A7. Yes the equipment intended is the Olympic Bumper Plate with sizes that range from 10-45 lbs.
- Q8. Regarding specification for the Elliptical Cross-trainer / with arms – as stated is effectively a sole source specification. Could specification be generic and made to read, “Incline adjustable” instead?
- A8. Yes, on elliptical cross trainer with arms, specifications revised to read ‘Incline Adjustable’.
- Q9. Regarding upholstery on strength equipment. Wear guards are used where a less durable upholstery is used overall. More generic specification would indicate quality upholstery acceptable.
- A9. Premium quality upholstery is acceptable
