Further to the above-mentioned Invitation to Tender, this **Addendum #4** is to advise potential bidders of the following changes to this tender call and /or answers to Bidders questions received to date:

We have attached the Civil Specs and the Electrical Specs in French per the request received for the translation of the specifications (both) from English to French.

Upon reviewing the translated specs we found minor changes to be done to the English Specs as follows:

1. The **attached sections** Sections 31 23 33 - Excavation Trenching and Backfilling ; Section 33 65 73 - Concrete encased conduit banks; and Section 33 71 73 - Aerial electrical service; only have a revised header **to remove** “and Ramp”.

2. **Section 01 10 10 1.02 DESCRIPTION OF WORK**
 - .1 In general, work under this Contract shall consist of but not be limited to the following:
 - .1 The removal of **rock** protection as shown to permit new work. The **rock** will be stored on site as shown **on drawings** or as directed by Departmental representative.
 - .2 All excavated and un-recyclable backfill material including underwater excavated materials to limit of work will be stored on site as shown **on drawings**.



- .3 Extend existing PVC drain pipe as shown **on drawings**.
- .5 The construction of new concrete deck and Berlin wall as shown **on drawings**.

3. Section 01 33 00 1.03 SHOP DRAWINGS AND PRODUCT DATA

.13 The review of shop drawings by **Departmental representative** or its authorized Consultant is for sole purpose of ascertaining conformance with general concept. This review shall not mean that the **Departmental representative** approves the detail design inherent in the shop drawings, responsibility for which shall remain with Contractor submitting same, and such review shall not relieve Contractor of responsibility for errors or omissions in shop drawings or of responsibility for meeting all requirements of the construction and Contract Documents. Without restricting generality of foregoing, Contractor is responsible for dimensions to be confirmed and correlated at job site, for information that pertains solely to fabrication processes or to techniques of construction and installation and for co-ordination of Work of all sub-trades.

4. Section 01 35 29 1.12 HEALTH AND SAFETY PLAN

.5 Harmonize Plan with Facility's Emergency Response and Evacuation Plan. Departmental Representative will provide pertinent data including name of **Departmental representative** and Facility Management contacts.

All other terms and conditions remain unchanged.
