Q1: Is the contractor responsible for constructing the Snow Bridge at KM509 Kledo Creek Pit?

A1: **No**

Q2: Does PWGSC have all the environmental permits and approvals in place to commence the Snow Bridge Construction and hauling in KM509 Kledo pit?

A2: **Yes**

Q3: How much clearing and grubbing will be required in Kledo Pit?

A3: **None**

Q4: How much stripping will be required in Kledo Pit?

A4: **None**

Q5: How much dewatering will be required in Kledo Pit?

A5: **Should be frozen.**

Q6: How much frost is anticipated in the gravel pits?

A6: **Unknown**

Q7: Will the dozer hours be utilized for ripping the pit floor, in order to excavate the materials?

A7: **Yes**

Q8: Will the dozer hours be utilized in Kledo Pit or just KM689.1?

A8: **Both**

Q9: The completion date for BST production is **Extremely** unreasonable....20,000m3 of 12.5mm material in 4 weeks, while working in temperatures below minus 20. Will PWGSC provide an extension for the completion date to April 20th, 2018? This will allow for adequate time to complete the BST production, during extreme temperatures.

A9: **No extension.**
