SOLICITATION AMENDMENT 007

This Amendment is raised to:

- (a) Address questions; and
- (b) Revise the Solicitation.

The bid must take into account the following information:

Question 43

In reference to Annex B (Technical Statement of Requirements), Sections 3.3.6.3 and 3.3.6.4,

- a. Is there a preferred shape/size for the handles?
- b. Are both ends of the handle to be stitched to a common point, thus forming a loop, or are the two ends of the handle to be separated by some distance to form a semicircular handle.
- c. Is there a specification for loop/handle diameter?

Response to Question 43

- a. The preferred shape is a semi-circular handle.
- b. Refer to Revision 49 and Revision 50.
- c. Refer to Revision 49 and Revision 50.

Question 44

Are there drawings for the curtain boom that Bidders can reference our pricing? Or are Bidders to propose our design based on the technical specifications set forth in the tender documents?

Response to Question 44

There are no drawings of the curtain boom for reference for pricing. The goods and services proposed in a bid must meet the technical specifications set forth in the Solicitation.

Question 45

In reference to Annex B (Technical Statement of Requirements), Sections 3.3.3.5, 3.3.4, 3.3.6.3, and 3.3.6.4, we request that the allowance for individual fabric welds between floats be stricken, and only methods which maintain constant length of the boom be allowed, such as strapping or bulkheads. We also request that the specifications be altered such that the handles are sewn to the welded seam below the top tension, and not to the top tension member itself.

Response to Question 45

Annex B (Technical Statement of Requirements), Section 3.3.3.5 states, "Each curtain boom section must employ some means to preserve the original orientation of the floatation elements along its longitudinal axis (e.g., webbing straps or individual fabric welds)." The items listed in parentheses in Annex B (Technical Statement of Requirements), Section 3.3.3.5 are simply provided as examples.

Annex B (Technical Statement of Requirements), Section 3.3.3.5 and Section 3.3.4 remain unchanged.

Refer to Revision 49 and Revision 50.

Revision 49

In Annex B (Technical Statement of Requirements), replace Section 3.3.6.3 in its entirety with the following text:

“3.3.6.3. Each anchor point location must be indicated by a red webbing handle where each end of the webbing handle must be attached to opposite sides of the top tension member above the corresponding anchor point. The length of webbing and distance between the two attachment points must easily accommodate a gloved hand.”

Revision 50

In Annex B (Technical Statement of Requirements), replace Section 3.3.6.4 in its entirety with the following text:

"3.3.6.4. Each curtain boom section must have a black webbing handle where each end of the webbing handle must be attached to opposite sides of the top tension member at each fold point, provided that the fold point does not coincide with an anchor point. The length of webbing and distance between the two attachment points must easily accommodate a gloved hand.”
