The following questions and answers relating to the Request for Proposal are hereby incorporated into this solicitation amendment:

1	Is it possible to submit the bid to Fax Number: (819) 997-9776 provided at the first page of the tender document?	<p>As per solicitation 2.2 Submission of Bids</p> <p>Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid</p> <p>Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.</p> <p>Due to the nature of the bid solicitation, bids transmitted by facsimile to PWGSC will not be accepted.</p>
2	Section 4.5: what is a "Bid Evaluated Price" and how do you calculate the score of 65%? Is the base for this evaluation the charger unit price + NRE, the charging "slot" price + NRE or any other method?	As per Section 4.5 and the Annex B, Basis of Payment, summation of Tables 1,2,3,4, and 5 are tallied per section to formulate the final "Bid Evaluated Price". Each responsive bid will be prorated against the lowest evaluated price and the ratio of 65%.
3	From the previous Q&A it is not clear to us how to present the pricing: we understand the gross price will be formed from the charger unit price * 250 + NRE as elaborated in Annex B. correct?	Non Recurring Engineering, as well as any other pricing components, must be compiled and provided one price per required criteria.
4	Is it possible for you publish your original xls. pricing files and an original word/xls. document of the compliance table so that all bidders will work on equal files and formulas?	Annex B, Basis of Payment contain formulas with basic addition. Bidders are encouraged to input their pricing information directly in provided Basis of Payment Annex B documents.

5	Is it allowed to offer optional items or features that are not required in the bid, apart from the bid price?	Bidders are welcomed to propose optional features, as long as it does not impact any of the mandatory requirement and there is no additional cost.
6	Is it allowed to offer alternate configurations? In such case, which configuration will be evaluated?	A bid package must contain only one configuration.
7	Section 5.1.1.2: DC voltage range is 8-36V. Please clarify whether 8.0V is the correct value.	Eight to thirty six is the voltage range.
8	Section 5.1.1.1: Does customer have power sources with constant voltage supply of 90V AC so the max AC power input will be $P_{ac}=90V*15A=1350VA$, or it is just a safety value, so the system can be designed according to the nominal voltage $P_{ac}=120V*15A=1800VA$?	The charger must never draw more than 15Amps, it is the Bidders responsibility to ensure that limit is always met.
9	Is it allowed to use A4 paper sheets for the hard copies?	Refer to 3.1 of the solicitation, Canada requests that Bidders follow the format instructions described below in the preparation of their bid: (a) Use 8.5 x 11 inch (216 mm x 279 mm) paper;

		(b) Use a numbering system that corresponds to the bid solicitation.
10	Since there is an emphasis on "green" behavior, is there an alternative way of bid submission by email?	Refer to the response to question 1.
11	TPR, section 14.1 - Experience in Environmental Engineering Design and testing. Is it enough to present one project with the required tests and their respective evidence, or do we need to present more than one project?	It is the Bidders responsibility to present information in sufficient detail to ensure that all requested criteria are adequately addressed.
