AMENDMENT 004

1.0 Questions/Clarifications

- We need to know from consultants what the load of the uv system is as the solar system needs to be designed around total load of building. The solar system that is specified now is not big enough to handle all the load they have in the building. We need to know from engineers total load of building.
 - A9 The total design load of the water treatment system is 5,000 watts, 20 amps, 120/240 v. The solar panel system is to provide power to the treatment system only. As such, the hot water heater and space heater are to be deleted from the contract.
- Q10 Distribution: No breaker Schedule for new Panel (to be determined by Contractor).
 - Alo No panel schedule is provided as this is to be provided by the contactor responsible for the construction of the addition. The addition or the new panel does not form part of this contract. Once the panel schedule is confirmed, this information will be made available to the successful contractor under this contract.
- Q11
 - Q11a Unit Heater: Can't tell if its existing or not.
 - Alla The unit heater is not existing. As per response above, bidders should note that this item is being removed from the scope under this contract.
 - Q11b If not, according to attached spec they may require explosion proof heater and explosion proof stat?
 - A11b Heater is not required. Explosion proof would not have been required based on classification.
 - Q1 1c Also, no indication on KW required. Usually 10W per SQ FT roughly in a well insulated room with most heaters, pending what else in running in that same room.
 - A11c Heater is no longer required.
- Q12 Lights: Equipment list says 3 LED lights, one per room, but no luminaire schedule. Just a vague spec on Div 26 but if the heater is required explosion-proof the light might need to be as well.
 - A12 Explosion proof lighting is not required. Lighting is not included in this contract.
