This Amendment No. 006 is raised to answer the following questions:

Q1: Can revisions to a proponent's tender pricing be allowed to be faxed to PSPC?

A1: As per GI10 Revision of Bid found within R2710T General Instructions - Construction Services - Bid Security Requirements:

1. A bid submitted in accordance with these instructions may be revised by letter or facsimile provided the revision is received at the office designated for the receipt of bids, on or before the date and time set for the closing of the solicitation. The letter or facsimile shall be on the Bidder's letterhead or bear a signature that identifies the Bidder.
2. A revision to a bid that includes unit prices must clearly identify the change(s) in the unit price(s) and the specific item(s) to which each change applies.
3. A letter or facsimile submitted to confirm an earlier revision should be clearly identified as a confirmation.
4. Failure to comply with any of the above provisions may result in the rejection of the non-compliant revision(s) only. The bid shall be evaluated based on the original bid submitted and all other compliant revision(s).

Note: The other requirements within R2710T for the submission of bid remain unchanged.

Q2: When does PSPC foresee awarding the contract?

A2: PSPC anticipates awarding the contract by March 31, 2018.

Q3: We request an extension in the closing date of one week in order to provide the comprehensive submission that is required.

A3: Refer to Amendment 4.

Q4: It is noted in section SI06 of the Invitation to Tender document that we are required to use 8.5 x 11-inch size paper for the preparation of our bid. Could you please confirm that we may use larger size paper for the proposed schedule as well as the site layout?

A4: Yes. See amendment below.

Q5: Given the significant periods of poor weather conditions that can be encountered at the site, will PSPC consider providing the Contractor an additional working season to complete the project, at no penalty, if historically poor weather occurs during the regular contract period?

A5: The contract must be completed by March 31, 2020 as indicated in BA06 of the ITT.
