AMENDMENT NO. 4
HYDRAULIC PRESS, Garrison Petawawa

This amendment is raised to answer the following question asked by a potential bidder:

Question # 8 - One question has come up that could make a big difference in the size of the tonnage on the press brake and of course the price.

The revised spec say the following,
“Must be able to bend 3/8” Thick Mild Steel”

My question is what would be the largest width plate that the customer would like to bend at 3/8” thick mild steel?

Does the customer need to bend 3/8” plate that would take up the entire length of the press brake or could we base the calculation on a smaller width, e.g., bending 3/8” plate 60” wide.

Answer #8 - Between 6 feet and 8 feet length.

All other terms and conditions remain unchanged.
