The same as provided on other coastguard trucks I believe there has been a duplication, see 2.7.31 Stainless Steel/Aluminum (non-corrosive) exterior visor. As this type of visor is not recommended for heavy duty applications and is not available on our chassis.  <b>Question:</b> Is our composite visor acceptable?	2.8.12 – States: Roof mounted LED Marker lights (Spec.
