AMENDMENT 002

This Amendment 002 is raised to address supplier inquiries.

Questions and Answers:

Q3. On page 13 of 20, Annex "A" Statement of Work, 2. Objective; the Crown states "Furthermore, full University credits towards a recognized Occupational Health and Safety degree program will be attributed to successful students." Please confirm that it remains the Crown's intent that students taking the training provided by the successful vendor under this contract be awarded University credits pursuant to their successful participation in the 45 day training program and that it is the vendor's responsibility to verify at the time of bid submission that such an arrangement has been made.

A3. The intent is that whomever is successful with the bid is able to provide proof that a University will award credits toward an Occupational Health and Safety Degree. Previous contracts have included a letter from University of Cape Breton indicating that they would award 6 university level credits for the training. However, this is not required at time of bid submission, it is considered part of the deliverable requirement under Annex "A" and may be completed following Contract Award.
