Amendment:

A) Questions and Answers

- Q1: With respect Annex "A", Section 2.5.1, Dissolution System, item 3. We have wired temperature sensors and there will be no impact on testing. Can you please change this specification to "Wireless to Wired or Both"?
- A1: Wireless temperature sensors are a key feature affecting the performance and reliability of the instrument. We will not remove them from the specifications.
- Q2: With respect Annex "A", Section 2.5.1, Dissolution System, item 6, "Must have a self-priming circulator/heater". Our heater is not self-priming. Minimal impact on daily work. Our heater has much lower vibration than any other system. Can you please remove the "self-priming" specification?
- A2: A self-priming pump is important for simple operation and robust performance. We will not remove it from the specifications.
- Q3: With respect Annex "A", Section 2.5.1, Dissolution System, item 11, "Must store at least 100 user-programmed methods". Our system offers 30 method slots instead of 100. If you want to interface the system with Dissolution Workstation Software, there are no limits to this. Can you please change the specification to "Must store at least 30 user-programmed methods"?
- A3: After a review of our needs, we would be willing to accept a system that can store 30 user-programmable methods.
- Q3: With respect Annex "A", Section 2.5.1, Dissolution System, item 11, "Must store at least 100 user-programmed methods". Our system offers 30 method slots instead of 100. If you want to interface the system with Dissolution Workstation Software, there are no limits to this. Can you please change the specification to "Must store at least 30 user-programmed methods"?
- A3: After a review of our needs, we would be willing to accept a system that can store 30 user-programmable methods.
- Please see below for further changes/information.
- Q4: With respect Annex "A", Section 2.5.1, Dissolution System, item 12, (a), RPM Control Range: 25-300 RPM or wider. Flow rates for our autosampler are 6-12ml/min. Can you please remove the specification "RPM control range 25-300 RPM or Wider"?
- A4: We cannot agree to the prospective bidder's request to remove the RPM control range from the specifications.
