The following addendum supersedes information contained in the drawings and specifications issued of the project to the extent referenced. This Addendum forms part of the Tender Documents and is subject to all of the conditions set out in the contract documents. No consideration will be allowed for any extras due to any bidder not being familiar with the contents of this Addendum.

SPECIFICATIONS

1. DELETE Section 00 00 02 and REPLACE with the attached 00 00 02 Schedule of Quantities and Prices.

BIDDER QUESTIONS

- Q1. Is there a unit of quantity for the transportation and disposal of loose debris that the bidders can use? We have no idea what old materials, braces, pile stubs etc may be on the sea bed there that will be recovered once the deck has been removed?
- A1. No onsite seabed survey has been completed. The payment item has been updated on a per tonne basis to account for the risk in this item.
- Q2. The owner will pay for disposal of piles, timber and debris by weigh slips from a controlled facility. This assumes that any recyclable material must be disposed of in order to be paid for and that any materials not being disposed at a landfill but recycled into other uses will not have the transportation costs paid because disposal and transportation are linked in the units. Is that the correct interpretation?
- A2. Please find attached an updated bid sheet which breaks out the transportation as unit pay items. The disposal of these materials will be paid separately based on disposal site weigh slips per the original contract. If a contractor elects to "recycle" any materials disposal will not be paid.

Measurement and payment clauses for transportation of all material classes (Items 4a, 5a, 6a) shall be updated to read:

"Payment for transportation of deconstruction materials will be paid on unit price basis. Where the payment item is on a per tonne basis, skow displacements will be used to calculate the weight of the materials removed. It is the contractor's responsibility to record skow drafts at each corner of the skow at the beginning and end of the day. The department representative will confirm the draft measurements while onsite. Any non-deconstruction materials found on the skow will be deducted from the payment calculation using an appropriate material density and approximate volume."

- Q3. This is regarding the QC/QA for the fill product. Is there any specific ASTM test numbers that are required regarding the quality of the fill or are you looking for ARD (Acid Rock Drainage) testing for quality control only."

- A3. No testing criteria has been specified. It is the contractors responsibility to confirm that the materials provided meet the minimum "clean fill" criteria which can be provided upon request (per the tendered specifications).
- Q4. Is there any contaminated sediment removal? If yes, where and what is it? (ref. 013533 1.8.3)
- A4. There is no sediment or material specified to be removed from the site or around the piles.
- Q5. Who is responsible to disconnect the power to the aluminum box on the approach?
- A5. It is the contractor's responsibility to deconstruct the site including the power to the facility.
- Q6. If the idea is to "deconstruct" the wharf, who decides what is salvaged and what is slated for disposal. Will the departmental representative dictate where the salvaged material will go?
- A6. All materials are expected to be disposed of. If the contractor elects to salvage any materials it will be at their discretion and cost. No materials are anticipated to be salvaged or kept by the owner in this deconstruction process.
- Q7. Is the boat ramp adjacent to the wharf scheduled to be demolished in this contract?
- A7. No, the boat ramp will remain at the site following the deconstruction project.
- Q8. Pile Extraction - We have never been asked to fill a hole from a timber pile that has been vibro hammer extracted. The vibrations from the hammer in sandy soil conditions actually fill themselves as the pile is removed. We fear that trying to fill each hole with .4m will significantly raise the cost of the overall project budget for no good reason. We request that the engineer reconsider this requirement for the project.
- A8. This is a criteria of the contract by the owner and will not be removed.
- Q9. Please clarify bid item #4. Transportation and disposal loose debris recovered from the water lot. This item is LS. What does it include?
- Description says, measured per tonne of recovered loose debris transported and disposed of at an approved facility as per the contract.
- Is this still a LS item or per tonne?
- A9. This item has been updated to be paid on a per tonne basis. See attached bid sheet.
- Q10. Is there a link to the Spec mentioned in 35 05 51 Marine general site work Part 1 Clause

1.1 references Item .1. MA 2080 General specifications for moorings for aids to navigation?

A10. This is only relevant for barge navigation lighting requirements while onsite.

Q11. I am trying to understand the expectation of the gravel fill at Sandspit.

A11. The intent of the gravel fill is to infill the pile holes following extraction to prevent local sloughing and ground disturbance. This is an owner initiative and will not be removed from the contract.
