Response:

The wall along grid line 4, wall type W4, is a fire rated wall. Fire separation from the adjacent (future) building is required. Fire caulking is required in this wall only.

- .1** Smoke detectors to be part of security system devices.
- 1.3** **260534 ALSO CALL FOR MINIMUM 19MM CONDUITS. THERE IS NO SUCH CONDUIT DO THEY MEAN 16MM[1/2 INCH] OR DO THEY WANT MINIMUM 21MM[3/4 INCH] CONDUITS?**
- .1** 25 mm conduit (1") to be used for communication cables.
- .2** 21 mm conduit (3/4") and 16mm (1/2") to be used for security system.
- .3** Conduit and flex to be used for 30A equipment.
- .4** Power
- .1** Horizontal conduits to be installed from panels for distribution.
- .2** Bx cables drops to devices from horizontal conduits (max 3m drops).
