AMENDMENT NO. 003

This amendment is raised to revise the RFP and to answer bidders' questions.

RFP REVISIONS:

Revisions no.6 and no.7 were made to the French document and do not apply to the English document.

QUESTIONS AND ANSWERS

QUESTION 14:

Re: Amendment 1 QA #1

We are trying to understand why CIC has lowered the corporate experience threshold. A contract for two categories with a value of \$1M where only 60% was invoiced means that a single \$600K contract would comply. If the initial contract period was three years then one contract where 2 resources were placed half time could comply. This is far from the scenario described in the RFP.

As it stood the original criteria was better aligned with the RFP. This is a Tier 2 TBIPS which is for contracts greater than \$2M. While we appreciate the Pricing Schedule is for evaluation only, the Financial evaluation assesses pricing on a team for 15 resources per year which approximates to \$3.6M per year for five years or \$18M. Even if two contracts are awarded, if a Bidder cannot demonstrate only one (1) single PeopleSoft contract in the last five years' worth \$2M how can they be qualified for this one?

The new criteria will not provide CIC with a supplier who has the right experience for to fulfill the work as described and we suggest that CIC revert to the original corporate criteria which was not at all onerous for any Bidder who is suited to the work.

Answer 14:

Lowering MTC1 to \$1M was considered fair and reasonable. It opens up the requirement to more TBIPS Tier 2 suppliers with PeopleSoft experience. Your request was considered but the requirement will remain unchanged.
