- No payment will be made for unsubstantiated supplies.
- Materials and replacement parts totals exceeding \$250.00 must be pre-approved by the CSC Project Authority.
- Certain consumable supplies (such as but not limited to electrical tape, drill bits, minor lubricants, fuel for standard tools, wire nuts, etc.) are considered as part of the Contractor’s necessary tools. The Contractor must arrive at the work site with all standard tools and equipment necessary to successfully carry out the work.
- Laid Down Cost - The sum of the product and transportation, exchange, customs and brokerage costs. The Laid Down Cost is used to compare the total cost of a product shipped from different supply sources to a customer’s point of use.
- Mark-up Allowance – A percentage above the Laid Down Cost that includes purchasing expenses, internal handling, General Conditions and Overhead, and profit excluding applicable taxes.
- All prices/rates are all inclusive and Taxes extra, FOB Destination.
