Addendum Information

Please find below the changes to the contract documents as it pertains to public tender of the Penticton Airport, External Water Supply Connection.

1. Section 01 11 55 – Time of Completion, item 1.5 should read:
“The Contract Completion is stipulated to be forty eight (48) weeks upon contract award. The decommissioning tasks are to be done twenty six (26) weeks after completion and commissioning of the external water supply connection.”

Section 31 11 16 – Water Utility Distribution Piping, item 2.7.1 should read: “Contractor to install a water meter on each of the tenant’s buildings. In lots with multiple buildings, each building with water service connection will require a water meter installation. The number of water meters is estimated. Contractor to locate and confirm the quantity with a Departmental Representative.”
