1. The bidder **MUST** propose by name the resources designated for the following labour categories, as found below:

- b) One (1) individual for the category of **Project Manager**
- c) Two (2) individuals for the category of **Subject Matter Expert**

The Bidder **MUST** include within their proposal a detailed curriculum vitae (CV) for each proposed resource named in their proposal.

Each CV **MUST** include the following:

- a) A detailed description of the proposed resource's work experience (indicated in years and months);
- b) Education and professional designation attainments and all other academic credentials as outlined in the **Attachment 1 to Part 4, TSPS Flexible Grid**

2. The bidder must provide examples of at least three (3) projects within the past ten (10) years of a similar scope and complexity as the SOW. Similar scope and complexity may include without limitation:

- A. An economic assessment for a provincial, federal or municipal government, industry sector or private industry.
- B. An economic development plan or strategy for a provincial, federal or municipal government, industry sector or private industry.
- C. A technology research report for a provincial, federal or municipal government, industry sector or private industry.
- D. A project that reports on the results of industry/sectoral consultations with industry, academia, and or government
- E. A roadmap that identifies opportunities and barriers for a particular industry/sector
