

# 1. Extend the closing date to 20-FEB-2018 on the cover page of the ITT document.

## 2. Questions and Answers:

Question 1: The quantity of main combi fixtures was approximately 137, after the meeting it was changed to 110 as some were being done by CORCAN - Please confirm.

Answer 1: That is confirmed, CORCAN will be installing 27.

Question 2: Please confirm the quantity of sinks to install as all units appear to be combi units.

Answer 2: Confirmed 2 - the accessible sinks and toilets for E-1.

Question 3: For the new units, are shop drawings available?

Answer 3: Yes, they are Met Craft Toilet units.

Question 4: For the new units, will holes have to be cored?

Answer 4: Yes.

Question 5: For the sewer this is will be connected to, is PVC acceptable or does this have to be cast iron?

Answer 5: Cast iron.

Question 6: Are we to include caulking around the new fixtures?

**Answer 6:** CORCAN will apply the caulking.

Question 7: Is there a requirement for pipe insulation?

Answer 7: No.





**Question 8:** Is there a separate area set aside for the storage Contractor's tools instead of back and forth every day?

**Answer 8:** Yes, there is a Small tool area. Supplies will have to be set in Ranges according to amount of available room. The locked Job Box is approximately 24" X 6'.

**Question 9:** What is the exact count of fixtures outlined in the tasks? – quantities changed as per site instruction (need written confirmation for item #3, #4, and & #5)

### Answer 9:

- #3: 2 accessible sinks and toilets for E-1.
- #4: no sinks with the exception of the 2 accessible
- #5: 4 Shower drains and drain covers on E-1

**Question 10:** Will item 9 stating that "we will be responsible to carry out work not outlined in this contract" be treated as a change order & be a cost adder to the contract?

**Answer 10:** There will be a subsequent amendment to address this.

Question 11: Will Emailed Tenders be accepted?

**Answer 11:** Yes, please see the cover page on the top left corner. It is important that Bidders read the entire document.

**Question 12:** Solicitation amendment 001 has included Annex C.1 Proposed Basis of Payment. Is this to be included with our bid package and total price to match the total bid amount in BA03


