Solicitation Amendment No. 008

This amendment is raised to respond to Bidders' questions:

Q1: Canada's requirement at Article 1 of W847L-180101/A is for PN 1075083-1. The two drawings that were distributed on February 08 as a result of Amendment 006 (1089088 and 1089089) are not listed in drawing 1075083 or any of its sub-components. They also do not have the same details as sub drawings of 1075083.

Please confirm that Canada requires PN 1075083-1 and that drawings 1089088 and 1089089 distributed as a result of Amendment 006 should be disregarded.

A1: Canada confirms that drawings 1089088 and 1089089 distributed as a result of Amendment 006 should be disregarded and that the original drawings provide the information required.

The response to Question #3 in Amendment 006 will be provided in a forthcoming amendment on the Buy and Sell website.

This amendment is raised to revise the following:

At Part 6 - RESULTING CONTRACT CLAUSES

- 6.2 Requirement:

6.2.1 First Article Testing and Approval

1. The Client will carry out all required first article inspections and tests to verify conformance to the specified requirements prior to production.
2. The Client shall test one (1) first article units of the Distribution Box. Test data shall be verified by and to the satisfaction of the Client.
3. The first article shall be forwarded to the Client for approval within 30 days from the effective date of the Contract. The Client shall notify the Contractor, in writing, within 7 days of receipt of the first article of the approval or rejection of the first article. The notice of approval shall not relieve the Contractor from its obligation to comply with all of the requirements of the Contract. A notice of approval may be conditional on further action required by the Contractor. A notice of rejection shall state the reasons for the rejection.
4. The commencement of production prior to first article acceptance by Canada is at the sole risk of the Contractor.
5. Unless otherwise provided in the Contract, the Contractor may deliver an approved first article as part of the deliverable end items if it meets all Contract requirements for acceptance.

6. If the first article or first article test report is rejected, the Contractor, upon request, must provide additional first articles to repeat any or all first article tests. After each request for additional tests the Contractor shall either make any necessary changes, modifications, or repairs to the first article or select another first article for testing. The Contractor must then delivery another first article to Canada within 30 days of so being requested.

All costs related to these tests shall be borne by the Contractor.

7. If the Contractor fails to deliver any first article by its due date, or if any first article is rejected, the Contractor shall be deemed to have failed to make delivery by the due date and shall be in default under the Contract.

8. In this first article test clause,

"**approval**" means written notice to the Contractor accepting the first article as conforming with the specified contractual requirements.

"**first article**" means a preproduction model or sample, initial production sample, test sample, first lot, pilot lot, or pilot model.

"**first article testing**" means testing and evaluating the first article for conformance with contract requirements before or in the initial stage of production.

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
