Stage 2

Request for Proposal EP750-181458/B is the second stage of Request for Proposal EP750-181458/A. Request for Proposal EP750-181458/B has been sent directly to the bidders that were deemed compliant in the Stage 1 evaluation.

To participate in Stage 2, bidders must pass the Stage 1 evaluation. Interested bidders must submit their responses to the Stage 1 Evaluation Criteria (see “Stage 1” below) as soon as possible. Any bidder who wishes to bid at the second stage may do so, as long as there is sufficient time to carry out the Stage 1 evaluation process.

Stage 1

Public Services and Procurement Canada (PSPC) has a requirement for the supply, installation, and maintenance of vehicle crash barriers in Ottawa, Ontario. Equipment is to be received by March 31st, 2018. The installation is to be tested and operational by August 31, 2018. The successful proponent will be required to store the goods at their secure facility in between the time of delivery and installation.

Due to the nature of this requirement, the Request for Proposal will be evaluated in two stages.

In Stage 1, Bidders must respond to the following mandatory evaluation criteria:

	Criterion	How to Demonstrate Compliance
M1	The Bidder must demonstrate: 1. The capability to supply, install and maintain vehicle crash barriers. 2. Recent ¹ experience installing k-rated vehicle crash barrier in Canada.	The Bidder must: 1. Provide a written statement that they are capable of supplying, installing and maintaining vehicle crash barriers. 2. Submit a project reference for a recent ¹ project that involved vehicle crash barriers installation in Canada. The reference must include: a. The location of the installation site and address. b. The client’s name and contact information.
M2	The Bidder must hold a valid facility security clearance granted at the level of SECRET.	The Bidder must submit its current facility security clearance level.
M3	The Bidder must have at least three employed personnel who hold valid SECRET clearance.	The Bidder must submit the names and dates of birth of at least three employed personnel who hold valid SECRET clearances.

¹ Recent is defined as: Completed within the last five years.

Bidders must pass the Stage 1 evaluation to be invited to Stage 2.

In Stage 2, bidders will receive the complete statement of work and evaluation criteria. Bidders will be asked to provide technical and financial bids. Bidders who do not pass Stage 1 will not be invited to participate in Stage 2.
